Our goal is to provide you with a safe and nurturing place to continue to grow in Christ and prepare for living out on your own. It is important to remember that in being dependent on Jesus and living by His Word as the center of your life you will ultimately get to the place where you are able to live independent of any assistance other than His divine will for your life. By continuing to remain part of ChristTown's program you are agreeing to the following:

1. Support & adhere to ChristTown ministries program guidelines to aid in the recovery of those coming up behind you;
2. Not take any anti-depressant, narcotic pain killer(s), anti-anxiety or any other mind/mood altering medicines. Any medications you take must be approved in advance by the Men's Director.;
3. Attend all four Family Meetings administered by ChristTown;
4. CMI leadership panel will approve any outside employment with Pastor/Director having final approval;
5. Agree to random inspections of your living quarters, bags, dressers, bunks, phones and autos (if applicable);
6. Complete Money Management class as directed by CMI leadership within 90 days of signing this agreement; and
7. Make sure you read and understand the attached program agreement because violations of any rules set forth will be grounds for dismissal from the program.

Again, congratulations! I am praying that your journey will be as awesome as mine has been. Jesus is alive and He rescues and saves!

# *CMI Phase 2 Resident Program Agreement*

## ***E*ligibility**

Must have successfully completed CMI's one-year rehabilitation program and the following:

1. Interview with Pastor/Director and/or CMI leadership and receive approval from both to participate;
2. Program participants must be at least 18 years of age;
3. Complete and sign the CMI Phase 2 agreement; and
4. Submit a written request for admission into the CMI Phase 2 Program which will include a statement of why you want to go into this program and your plan for obtaining outside employment, a personal automobile, an apartment, etc.

## ***E*valuation *P*eriod**

Each resident will still be subject to:

1. A criminal Background Check through FDLE and check of Police records of arrests and outstanding warrants;
2. A Sexual Offender/Predator check; and
3. Random drug test(s) at will.

At this point of your recovery we pray there are little to no issues with obedience to the program rules and leadership...this should remain a constant in your new life! CMI reserves the right to remove any participant from the program for not adhering to the biblical way of living.

## **Residents' Responsibilities**

As you are now fully aware, the foundation of our rehabilitation program is based on the Word of God, so in order to continue to equip you for your future, you will be expected to:

- Attend all devotions at the CMI house, church services at CMI, and other churches as directed.
- Practice every day what you learn in classes, church, studies and devotions.
- If not working full time elsewhere, you will still be expected to volunteer in the ChristTown Ministries Bargain Center or Community Church as directed by the Pastor/Director or CMI Leadership.
- Attend all mandatory house meetings and groups.
- The CMI Phase 2 Resident Program Agreement will supersede the first year CMI Resident Program Agreement. Continue to follow all house rules & procedures as laid out in the original CMI Resident Program Agreement and this agreement you signed. You will now be held accountable for all house rules & procedures as laid out in the CMI Phase 2 Resident Program Agreement.
- Attend Relapse Prevention classes each week.
- Attend all four Family Meetings administered by CMI.
- Accomplish attached list of requirements for graduating Phase 2 of CMI's residential recovery program.

If a resident fails to do these things, he will be given a Disciplinary Action Form, which will result in a loss of privileges and/or dismissal from the program.

## ***P*hase 2 graduations requirements:**

- 1) If resident is 55 years old or younger, they must get their GED/High School Diploma
- 2) Driver License (if possible)
- 3) College degree, Certificate from Trade School, or satisfactorily employed
- 4) Auto/transportation (if possible)
- 5) Enough money saved to move into own place
- 6) Employed for minimum 3-6 months
- 7) Evidence can satisfactorily handle money without using
- 8) Satisfactory attendance to all church services, relapse prevention meetings, and Bible Study Group
- 9) Satisfactory completion of assigned Bible Study book
- 10) Satisfactorily resided over minimum of 12 Relapse Prevention meetings
- 11) Demonstrates through character that he is ready to be on his own
- 12) Approved plan for moving out and into own place.

# House Rules and Procedures

**AWAKE TIME:** Monday-Friday you will need to set your clock early enough so that you can come to the morning devotion at 5:55 am. Attendance and punctuality are expected.

**CURFEW:** Sunday through Thursday nights, the curfew is 10:00pm. On Friday and Saturday nights, it is 10:00pm. The doors will be locked at curfew so all residents must be inside the house at this time unless prior arrangements have been made with CMI leadership.

**BIBLE STUDY/CHURCH:** Attendance and punctuality are expected at the following:

*Morning group	Monday-Friday at 6:00am
Evening group	Monday-Thursday at 6:30pm;
Sunday mornings	Church service at 10:00am;
Wednesday evenings	Church service at 7:00pm.

\*See Attached List of Approved Bible Studies to be used for morning group.

**QUIET TIME:** As posted in your house.

**VISITORS:** No visitors are allowed in the CMI program homes. After you have been in the program for 60 days, all of your family and friends are welcome and encouraged to attend our Wednesday night and Sunday morning church services. However, residents will not be allowed any communication with family or friends until they have been approved by CMI leadership for visitation. Church services are held in our chapel at 2121 W. Jefferson St. Quincy, Florida.

**HEAT/AC:** All windows must remain closed when the heat or air conditioning is in use at ChristTown. The thermostat is set by CMI leadership and residents are not allowed to adjust it. It is *very important* to conserve electricity in order to keep operating costs as low as possible.

**DRUGS, ALCOHOL, WEAPONS, FIGHTING, PORNOGRAPHY, PROFANITY OR INSUBORDINATION** toward CMI leadership or anyone else will not be tolerated. Your room, back packs or any other storage area on our property are subject to inspection, by CMI leadership, at any time whether you are present or not. Drug and/or alcohol testing can also be conducted at any time. You could be required to go off-site to obtain your test, at your expense if necessary.

**KEEPING OUR FACILITY CLEAN** and orderly is a high priority. You will be expected to keep your area clean and pitch in to keep the entire property clean.

**DRESS CODE:** Men are not to wear muscle shirts or tank tops at any time while in any public place. Shirts of this type are allowed at home only. Your chest should be completely covered. Keep your shirts buttoned! Shorts are to be an appropriate length (when standing with hands down at sides, length should be to or below your fingertips). The tops of pants (including shorts) cannot be worn more than 2 inches below your natural waist. Residents can't show their underwear or butt crack.

**Sexual misconduct will result in immediate termination.** CMI believes in abstinence from sex unless you are married and then sex only with your spouse.

**TELEVISION/RADIO VIEWING/LISTENING HOURS:** Follow house rules. No audio devices are allowed except when approved by CMI leadership.

Secular music will not be allowed. ALL movies/videos must be approved by CMI leadership prior to viewing or listening to while you are in the program. *Only PG/G Rating will be allowed.* Listed below are all approved movies/videos in this resident's existing collection:

**MAIL:** To protect the privacy of all residents, only the staff will get the mail out of the mailbox. Under no circumstances will residents be allowed to get the mail or tamper with another person's mail. All residents are required to have their mail sent to:

2121 W Jefferson St.  
Quincy, FL 32351.

CMI does not allow personal mail to come to the residential house address. CMI reserves the right to review all incoming and outgoing mail. All outgoing mail must be processed through ChristTown leadership. Residents cannot place mail in the mailbox without prior approval from a ChristTown leader.

**USE OF TOBACCO PRODUCTS:** In designated smoking areas only!! Ask a member of CMI leadership and you will be shown where these are. No use of tobacco products is allowed when participating in any CMI group activity, which includes attending services at other churches, shopping at a grocery store or Walmart, delivering or picking up donations; during outside employment; riding in any vehicle, etc.

**FURLOUGHS:** A Resident Request form must be completed & approved for any outside, off-campus activity. Please note that requests are just that, requests. Furloughs & off-campus activities are not automatic; the requests are taken before the leadership team to determine eligibility and time resident will be allowed for the request. All forms must be turned in a minimum of 72 hours in advance of the activity resident would like to participate in.

Furloughs & off-campus activities will be allowed under the following criteria:

1. Resident must be caught up on all his required work including any additional work given for Disciplinary Actions
2. Resident must not have any Disciplinary Actions within the previous 30 days prior to date of furlough

3. Resident must have someone that agrees to take care of his chores while he is gone
4. Must be at least 30 days since last furlough
5. Either the individual(s) with whom resident is staying during furlough have completed all Family Meetings; or resident has completed all four Family Meetings administered by ChristTown.

Furlough time is determined by leadership team. Furlough can be approved to any amount of time up to maximum time of leaving at end of workday on Friday and returning Sunday morning to 2121 W Jefferson St. by 9:45 am to attend the regular Sunday morning worship service. Furloughs approved during holiday times shall count as a regular furlough and included in the 30 days since the last furlough requirement. Holiday furlough days and times will be determined case-by-case.

**FOOD:** No food will be allowed in assigned sleeping areas.

**LAUNDRY:** Each resident is responsible for doing his own laundry. If there are assigned laundry days in your house, you must comply.

**OUTSIDE EMPLOYMENT:** Outside employment is allowed after a minimum of one year and approval of CMI leadership.

**FUNDS AGREEMENT:** Any outside money received, including Social Security, disability, unemployment, and government checks, will be charged 30% of the total amount as a program fee. All excess money will go into a resident account and will be given to the resident on an as-needed basis, as determined by CMI leadership. A 24-hour advance written request from the resident is required to receive the funds.

If a resident of the CMI Residential Program leaves the program for any reason while owing a program fee to ChristTown Ministries, and he subsequently wishes to re-enter the program, the delinquent program fee must be paid prior to re-entry into the program.

**Remember: We are on your side!**

If a resident chooses to leave the program before the scheduled time, the resident must submit a written request for funds in their resident account 72 hours in advance of leaving. If the resident leaves before the 72-hour period is up, all funds remaining in their resident account are forfeited to the program. This money will be considered a donation and transferred to CMI's general fund. The 72-hour period is for your protection, to keep you from making an emotional decision.

If a resident is expelled from the program, he forfeits all funds remaining in his resident account. This money will be considered a donation and transferred to CMI's general fund.

**TRANSPORTATION:** Residents must arrange for all appointments (including court appointments and doctor appointments) with ChristTown leadership 48 hours in advance of the appointment. Health emergencies will be handled on an as-needed basis. **ABSOLUTELY NO RESIDENT IS TO TRAVEL ALONE IN ANY CMI VEHICLE!**

**PHONE PRIVILEGES:** The following has been agreed upon between \_\_\_\_\_ and CMI regarding the use of/having a telephone:

**COEXISTING:** All residents are expected to treat each other with respect. No arguing, name-calling, gossiping or complaining will be tolerated.

**MOVING IN:** Space for storing personal items will still be limited. The items you intend to move must be approved by CMI leadership prior to the move.

**MEDICAL:** *We are not a medical facility!* If you are not physically able to work, you are not eligible for our program.

- Any medical expenses incurred by you during your stay at CMI are your responsibility.
- CMI does not pay for medicines.
- CMI does not allow you to take any mood/mind altering medicines (medication such as for blood pressure and insulin are ok).
- All medicines must be approved in advance by CMI leadership.

**LEGAL ISSUES:** All outstanding warrants must be taken care of within fourteen (14) days of entering the program. Your legal issues are your responsibility. Communication with the CMI leadership and legal authorities is crucial and is your responsibility. CMI leadership must be notified immediately when you enter the program of any outstanding legal court dates, issues, etc.

**WALK-OFFS:** A walk-off is defined as any program participant who purposely, knowingly and willingly leaves ChristTown's authority for any time-frame.

- There will be a waiting period of up to 30 days (as determined by leadership) before participant can be considered for program re-entry.
- Upon re-entry, participant will start the program over, as any other brand new program participant would.
- Participant must make their own way back to ChristTown.
- Approval of CMI leadership is required for re-entry. Participant must heed to any other special requirements placed by CMI leadership.

**US GOVERNMENT FOOD STAMPS:** ChristTown believes and trusts in the Lord for providing all of our needs. Therefore, no program participant shall receive food

stamps during their involvement in the CMI program. Any resident currently receiving food stamps will be required to return the food stamp card to the appropriate government agency and terminate their involvement in the program.

**FAMILY MEETINGS:** When a participant re-enters the CMI program after having been out of the program for 6 months or longer, family members must attend all Family Meetings again

## Disciplinary Action (DA)

Disciplinary Actions are formal, written documents that describe the offense and the date(s) when the offense happened. A Disciplinary Action will be issued by CMI leadership if you commit an offense. An offense is defined as the breaking of any rule set forth in this agreement or in the CMI house rules and procedures.

*Examples are:*

- Failure to come to, or tardiness to, church services, classes, or house meetings;
- Sleeping in class;
- Failure to work the program;
- Having an un-approved visitor;
- Excessive conflict with other residents or CMI leadership (verbal arguments will not be permitted.) (*Physical fighting or threats of physical harm is grounds for immediate expulsion.*);
- Tampering with thermostat settings;
- Smoking in any place other than designated areas.

Disciplinary Action Forms are kept in your permanent records and three (3) or more are grounds for Expulsion from the program. DA's will be available to judges, probation offices, other agencies, etc.

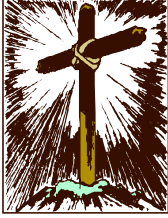
## **Expulsion (or Dismissal) From the Program**

Occasionally, residents must be dismissed or "expelled" from the program prior to completion of the restoration program when they fail to follow the terms and conditions set forth in the CMI Phase 2 Resident Program Agreement. The following list provides some examples of offenses that are grounds for immediate expulsion. However, this list is not comprehensive but rather is intended to provide you with an idea of the type of offense that will lead to expulsion:

- 3 Disciplinary Actions (for any offense);
- Sowing discord (Proverbs 6:16-19) repeatedly or after your grace period;
- Physical fighting (or threats of physical harm) with anyone, residents and staff included;
- Use and/or possession of illegal drugs; positive drug test other than the one you were given immediately upon your entry into the program;
- Possession of firearms or other weapons;
- Destroying or stealing property (CMI will prosecute anyone caught stealing.);
- Rude or demeaning behavior toward others, including CMI residents and staff members;
- One or more nights away from the men's house without advance permission;
- Knowingly allowing a non-resident to come to the CMI residence.

ChristTown also reserves the right to expel residents for any other reason that causes significant disruption to the program's operations.

If you leave or are asked to leave the program for any reason, anything left behind, including any funds in your resident account, will be disposed of at CMI's discretion. Re-entry into the CMI program must be approved by the CMI Men's Director and the Pastor/Director.
